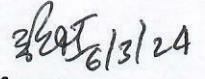
सूचना

नोट: भर्ती के अगले चरण हेतु अब किसी भी आपत्ति पर विचार नहीं किया जायेगा।

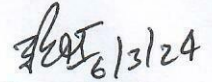
